

Dear Parent/Guardian:

This is an exciting time as your child prepares to enter kindergarten in the fall. A complete immunization record must be presented to the school office when you register for the school year. Wisconsin Immunization Law requires your child to have the following immunizations:

- 4 DPT/DtaP/DT immunizations (** 1 dose must be received on or after their 4th birthday. (Note that for children that are on schedule, this will be their 5th dose.)
- 4 Polio immunizations
- 2 MMR immunizations
- 3 Hepatitis B immunizations
- 2 Varicella (chickenpox) immunizations OR the date of the disease

The Oneida County Health Department (715-369-6111) or your child's doctor may assist you with the review of your child's immunization record to determine if your child is in compliance with Wisconsin State Law.

Waivers are available for religious, health and personal conviction reasons. You may sign for this on the bottom of the immunization record available from your child's school. (See attachment). However, in the event of an outbreak of a vaccine preventable disease, students with waivers may be excluded from school until the outbreak subsides.

You are encouraged to have your child immunized well in advance of the school opening to avoid the late summer rush. Please contact your physician or the Oneida County Health Department if you have further questions.

As of 2003 state law requires school districts to encourage parents of kindergarten-age students to provide proof of eye examinations to the school: [118.135, Wis. Stats.] states that each school board must request that parents/guardians provide evidence that the student has had his/her eyes examined by a licensed optometrist or licensed physician.

Parents/guardians who choose to have their child's eyes examined should provide evidence of the eye examination or evaluation by December 31, following the student's enrollment in kindergarten. Attached is the state form that has been specifically designed for this purpose. Please return the completed form in the fall to your student's school. (This should not be mailed with your registration.)

STUDENT IMMUNIZATION RECORD

INSTRUCTIONS TO PARENT: COMPLETE AND RETURN TO SCHOOL WITHIN 30 DAYS AFTER ADMISSION. State law requires all public and private school students to present written evidence of immunization against certain diseases within 30 school days of admission. The current age/grade specific requirements are available from schools and local health departments. These requirements can be waived only if a properly signed health, religious or personal conviction waiver is filed with the school. The purpose of this form is to measure compliance with the law and will be used for that reason only. If you have questions on immunizations or how to complete this form, contact your child's school or local health department.

 AGE/GRADE REQUIREMENTS
 2014 SCHOOL YEAR AND BEYOND**

The following are the minimum required immunizations for each age/grade level. It is not a recommended immunization schedule for infants and preschoolers. For that schedule, contact your doctor or local health department.

1. DTP/DTaP/DT vaccine for children entering Kindergarten: Your child must have received one dose after the 4th birthday (either the 3rd, 4th, or 5th dose) to be compliant. (Note: a dose 4 days or less before the 4th birthday is also acceptable).
2. DTP/DTaP/DT/Td vaccine for all students Pre K through 12: Four doses are required. However, if your child received the 3rd dose after the 4th birthday, further doses are not required. (Note: a dose 4 days or less before the 4th birthday is also acceptable).
3. Tdap means adolescent tetanus, diphtheria and acellular pertussis vaccine. If your child received a dose of a tetanus-containing vaccine, such as Td, within 5 years of entering the grade in which Tdap is required, your child is compliant and a dose of Tdap vaccine is not required.
4. Polio vaccine for students entering grades Kindergarten through 12: Four doses are required. However, if your child received the 3rd dose after the 4th birthday, further doses are not required. (Note: a dose 4 days or less before the 4th birthday is also acceptable).
5. The first dose of MMR vaccine must have been received on or after the first birthday (Note: a dose 4 days or less before the 1st birthday is also acceptable).
6. Var means Varicella (chickenpox) vaccine. A history of chickenpox disease is also acceptable.

The State of Wisconsin encourages parents of Kindergartners to arrange for their child's eyes to be examined by an optometrist or evaluated by a physician by December 31 of the child's first year in school. An examination or evaluation should include, at a minimum, the elements listed below. (By checking the box, the examining doctor is indicating that the element checked was performed.)

- Brief history (general health and eye health) of the child, including family history
- General external observation of the child's eyes and surrounding structures
- Ophthalmoscopic examination through an undilated pupil
- Gross measurement of peripheral vision
- Evaluation of eye coordination and function (alignment and motility)
- Visual acuity for each eye (separately)
