in athletics or extracurricular activities. I understand I will need to provide this information to the Activities Office at the end of each school district grading period regardless of whether or not my child is currently active in an athletic or extracurricular activity. Quarter and Mid-Term eligibility reports will also be required for actively participating students.
