Coaches must waive the admission/fee of any student who is of free/reduced status.		<b>Outdoor</b> **If attendees of the event are paying admission/fees directly to coaches/advisors, the coach or advisor will be responsible for paying the district <u>5%</u> of the gross income. Gross income will be reported to the Business Office in the form of documentation of the number of attendees and the price of admission. Coaches must waive the admission/fee of any student who is of free/reduced status.	
<b>Adult Oriented Groups</b>	1. Activities primarily intended for the adults of the School District of Rhinelander and Community.	\$15.00	\$30.00	\$15.00	\$30.00
	2. Groups which request and obtain a written reciprocity agreement or a written individual negotiated agreement.	Rates charged as per individual agreement negotiated with the district. This option is intended for those groups within the community that desire to use district facilities on a continuing basis and who may have something to offer the district in return.			
	3. Approved reduction or waiver of fees approved by the Board of Education or its designee.	This option is intended for those adult community groups that may desire to use the facilities but qualify under a hardship or non-funded situation and do not have the resources to pay for facility use. Application for waiver or reduction of fees must be submitted in writing to the Board of Education or its designee on an individual basis (a request and approval may cover multiple areas or dates if identified in the request).			
<b>*Non-Local Groups</b>	Any activity sponsored by an organization that is not located in the district.	To Be Determined			

\* Charges for activities of non-local groups will be considered on an "as requested" basis, but will be no less than 2 times the rate for School District of Rhinelander community adult rates.  
 \*\* If there is no admission/fee charged to the attendees of these events, the building usage fee would be waived entirely. If the attendees' admission fee is being paid to a co-curricular support group registered with the School District of Rhinelander, the usage fee would be waived.

**NOTE: Coaches and advisors will be excused in part or in whole from their fee obligation if they recruit or retain traditionally underserved students into their co-curricular program.**

All groups will be responsible for any charges incurred. Example: Custodian, lifeguard, kitchen supervisor, stage or lighting operator.  
 CAVOC and the Ropes Course will be charged as per current School District of Rhinelander policy.  
 Areas not listed on a facility use request will be determined to be in a large area or small area on an individual basis, as requested.
